1. National Trends – Dr. Cheryl Charlton

Also, working on a system or tool to detect plagiarism and implementing it in the classroom. It is not instilled in Schoology as much as it was in Blackboard. Lastly, October is Cyber Security month. The most important task you can do is to keep your devices updated for security.
